The Coordinator's Report

Who can say no to free pancakes?

Especially when the Lawn Fire Company volunteers are serving them up! Conewago Initiative will host our largest summer event of the year this Saturday, July 28 at the Lawn Fire Hall on Route 241 in Lawn. Come eat your fill of pancakes from 8 AM to 10 AM and mingle with Initiative partners. Then, join us for a tour of the watershed from 10 AM to 12 noon, where we will visit three landowners who have implemented conservation practices.

As you will see when you join us for the tour, we continue to make great strides in conservation planning and working with Conewago farmers to implement best management practices to improve water quality. We also now have an equivalent program for



homeowners in the watershed. We are partnering with LandStudies to offer free "Green Masterplans" for interested landowners. Our grant dollars will also fund the installation of stormwater best management practices (like rain gardens, meadows, and riparian buffers) identified in those plans.

And while seeing the results of improved water quality takes time, there are some positive early signals. As you will read below, fish sampling conducted this summer at the

Hershey Meadows stream restoration project resulted in double the number of fish species since the last time the site was sampled in 2007, before the restoration. That's exciting news, not only for Conewago partners and landowners, but for the Conewago's smallmouth bass, swallowtail shiners and banded darters, too!

Free Pancake Breakfast and Watershed Tour in Lawn on July 28th

The Conewago Creek Initiative will sponsor a free pancake breakfast and watershed tour, beginning at the Lawn Fire Company, Route 241 in Lawn on July 28, 2012 from 8:00 AM – 12:00 PM.

This summer watershed event invites the public to learn about, and visit restoration and conservation projects that the

Conewago Initiative has implemented.

The event will begin at 8:00AM with a free pancake breakfast. The pancake breakfast will seek to engage all Conewago Creek residents—farmers, homeowners, business owners, and municipalities that live and work in the watershed. Residents will get the chance to interact

with initiative partners and leave with a better understanding of their immediate impact on the watershed.

The tour of the watershed will begin at 10:00AM. There will be three main site visits showcasing the work of the initiative. The

Brown Residence features extensive native plant landscaping, the Hanson Farm will explain the benefits of no till planting and riparian buffers, and the Wenger Farm will show the importance of stream bank fencing and how to better manage cattle water access. On the tour, participants will get the chance to ask farmers and

homeowners alike about their land management practices. A watershed tour map will be provided, showing the locations of these three sites as well as highlighting 8 other properties and their conservation practices along the route.

Summer Fish Survey Shows Signs of Recovery



On June 28th, a fish survey was conducted on the Conewago Creek, at the Hershey Meadows restoration site in Lancaster County. This restoration project began in 2009 on Hershey Trust property, to repair nearly a mile

of eroded stream banks and create 15 acres of wetlands and 20 acres of forest between routes 743 and 283, adjacent to the Rail-Trail recreational path.

Fish surveys are an important method of water quality monitoring, as fish

species are a good indicator of ecosystem health. This survey was conducted using electrofishing gear, an approach that stuns fish temporarily without harming them. This fishing method is used in order to learn about the number of species present, abundance, and size of fish in the stream.

Matt Kofroth of the Lancaster County Conservation District led the survey and was assisted by local naturalist, Larry Coble. Volunteers from the DEP, Milton Hershey School, Conservation Districts, and Penn State helped to catch and identify the fish.

The survey provided excellent results, including 24

species of fish. (2 Perch species, 6 Sunfish species, 1 I Minnow species, 2 Catfish species, Sucker Species, and I Killifish Species). 3 of the species are classified as "intolerant," designating them indicators of high quality water.

Overall, the survey showed improvement in the creek, when compared to past historical fish survey data. The bank stabilization and forested riparian zones have made significant improvements in the creek's overall quality, resulting in improved aquatic health. Conewago Featured at Bay Executive Council Meeting

On July 9, the Conewago Initiative was featured on the agenda of the Chesapeake Bay Executive Council's annual meeting at Guston Hall in Virginia, the historic residence of George Mason. EPA Administrator Lisa Jackson, PA DEP Secretary Michael Krancer, Maryland Governor Martin O'Malley and others got to hear firsthand about the

Initiative and the wonderful work Conewago residents and partners are doing to implement best management practices and improve water quality in the watershed.

Matt Royer presented on behalf of the Initiative, reporting that the Initiative's work over the past two years has resulted in over 45 conservation plans written, 5,000 feet of stream bank fencing installed, 31 acres of forest riparian buffers restored, and 21,000 feet of terraces built in the Conewago watershed.

Amending the Conewago Creek Watershed Restoration Plan

In 2006, the Tri-County Conewago Creek Association partnered with RETTEW Associates to create a Conewago Creek Restoration Plan. This plan included 129 locations along the Conewago Creek and its tributaries that were in need of restoration.

Since then, all of the Conewago Creek Initiative partners have been working to restore these sites to reduce the Total Maximum Daily Load (TMDL) coming out of the

creek and heading into the Chesapeake Bay. This simply means we have been trying to make the Conewago Creek cleaner so that the Bay can become cleaner.

Now, 6 years later, the Initiative and its partners are going to be creating an amendment to the restoration plan. It will explain the work that has been completed, and identify more sites that have since been identified as needing restoration.

The addition of this

information will help make the watershed eligible for more funding and will help prioritize outreach and restoration efforts. This is one of the few amendments that have ever been created for a watershed plan and will help pave the way for other watershed organizations to update their plans.

This amendment will help show that we have come a long way but still have a ways to go before the Conewago will be clean and healthy.



Conewago Partner Spotlight: LandStudies, Inc

The Conewago Initiative is partner with excited to LandStudies, a design/build environmental restoration company from Lititz, PA. Their mission is to restore and improve natural systems through a holistic approach resulting in functional, natural landscapes. They will be providing stormwater assessment and planning services to landowners in the Conewago Creek watershed through our Stormwater Incentives Program.

LandStudies' signature Green Masterplan provides a guide for landowners with ideas on how to manage their property to improve water quality. Interested landowners have the opportunity to receive a free Green Masterplan from LandStudies through the Initiative. This will include an initial site visit, the Green Masterplan itself, and a guide on native plants and maintenance.

LandStudies has over 20 years experience designing and installing native plant habitats, restoring degraded streams, and implementing stormwater best management practices. By helping landowners to understand how stormwater can be managed effectively, water quality improvements are sure to occur. Practice Spotlights

On The Farm: Stream Bank Fencing

When cows have full access to streams they damage the stream banks by ripping out the vegetation that holds soil in place. They also add harmful bacteria to the water which can create health effects for the cows drinking the water and people swimming downstream. Installing stream bank fencing to limit the cows' access to the stream can solve these problems. Funding is available

to help install the fencing and alternative water sources. For more information contact your County Conservation District.



Around The Home: Rain Barrels

Stormwater runoff is one of our streams' biggest sources of pollution. Rain barrels can be used to collect and store water from your roof that would otherwise be lost to a storm drain. Once the water is collected, it can be used to water yards and gardens, wash cars, as well as for other outside uses. Using rainwater for your outside water uses will

reduce your water bill and have a positive environmental effect. Stormwater management means keeping rainwater where it falls.

Samuel Haldeman's 200th Birthday Celebration on August 12th

Join the Conewago Creek Initiative at a summer outreach event on August 12th! The Haldeman Mansion is joining with the Conewago Initiative to host a 200th Birthday Celebration for Samuel Haldeman, a famous American scientist and naturalist.

Samuel Haldeman was born at the mansion on August 12, 1812, in Bainbridge PA. Mr. Haldeman attended Dickinson College yet left after two years, claiming that "I cannot learn from others. I must see for myself."

Mr. Haldeman became a self-taught naturalist and scientist, studying everything from paleontology to fresh water snails and shells. Aside from science, Haldeman was also an accomplished linguist, studying the origin and historical development of words. When Samuel Haldeman died on September 10, 1880, he left behind him more than 200 publications in six separate disciplines.

The event will occur from 12-5pm at 230 Locust Grove Road, in Bainbridge, PA. The celebration will include historical bus tours of Marietta, a

stream sampling activity, mollusk presentations, fish print t-shirt making, games, cupcake decorating, and plenty of food! There is a \$5 parking fee and admission is free.
