## Green Infrastructure Planning in Colebrook

A team of Penn State researchers, as part of the larger Greening the Lower Susquehanna grant, have been working with communities in Dauphin, Lebanon, and Lancaster



Counties to conduct green infrastructure visioning sessions. The 3 meeting series helps the Penn State team learn what is valuable and desired in the communities. By the end of the process, the communities are presented a plan that they have helped design. The plans focus on tree plantings, native meadows, rain gardens, and

other practices that will not only beautify the communities but provide wildlife habitat and improve water quality.

The most recent community participating in this process is the Village of Colebrook. The first visioning meeting was very successful with the importance of the Conewago Creek being identified and appreciated. Two

additional meetings will be held in the coming weeks. One will focus on the benefits that plants can provide and the final meeting will allow the residents of Colebrook to brainstorm a green infrastructure plan for their community.

The final plan, prepared by Penn State Landscape Architecture students, will set Colebrook up for do-it-yourself projects as well as implementation grants. The Village of Colebrook, in its small square mileage, already contains several wildflower meadows, a rain garden, and forested areas.

This enthusiastic community is excited to be making decisions that can help the Conewago Creek.

Other communities that Penn State has worked with through this project are the Oakmont Neighborhood in Dauphin County, the Creekside Community in Lebanon County, and the Grandview Chase and Village Grand communities of Lancaster County. ## Live Staking: Webinars, Harvests, and Plantings

Winter is still very much upon us right now, but live staking season is right around the corner. To learn more about live staking, a webinar is available on the Penn State Extension website:

This webinar was presented by Kristen Kyler, Conewago Initiative Project Coordinator, and Jenn Fetter, Penn State Extension Educator. It provides step by step instructions on how live staking can be done on a stream in your own back yard. It is an easy and inexpensive method for improving eroding stream banks.



To get the live staking season started in the Conewago Creek watershed, a live stake

harvest will be held during the day on Friday, March 27. If you are interested in volunteering and helping to cut live stakes for use in local projects, contact Kristen at 717-948-6609 to find out additional details.

The first live stake planting of the season is scheduled for Saturday, March 28th from 9 AM-12 PM in the neighboring Quittapahilla watershed. The planting will be held at the Quittie Wetland Education Center in Lebanon where a riparian buffer was planted in the fall. This live staking project will help fill in the gaps where trees couldn't be planted last year to improve the banks of the stream and the functioning of the wetland system. ## Creekside Community Water Fest being Planned



The Village at Creekside in Lebanon County participated in the Green Infrastructure visioning process with the Penn State team as described in the article on Page 2. By going through the visioning process, the participating community members decided that a grass meadow riparian buffer supplemented with trees and wildflowers would create a zone for wildlife that could be enjoyed by all of the residents. A walking path will provide access to the creek and provide an opportunity for users to connect with the planting. Snitz Creek,



## “Gardening with Nature” Series Hosted by Master Gardeners

The Penn State Master Gardeners of Cumberland County are hosting their annual workshop series titled “Gardening with Nature.” These workshops include programs on plant communities, bird-friendly gardening, rain garden plantings, garden-worthy Pennsylvania native plants, invasive plants, backyard meadows, and garden design basics.

The first workshop will be instructed by Kristen Kyler of Penn State’s Lower Susquehanna Initiative. She will present “Green Your Blues” on Tuesday, March 10, 2015, from 7:00 to 8:30 PM, in the lower level

community room at the Cleve J. Fredricksen Library, 100 N. 19th Street, Camp Hill. Kristen will review the “Homeowner’s Guide to Storm Water” and share ideas for incorporating rain gardens, rain barrels, native meadows, and tree plantings into your landscape. By using the right plants in the right places, you can create gardens that can help soak up extra rainwater – water that might otherwise carry harmful pollutants into our local waterways.

Everyone interested in healthy gardening and a cleaner environment is welcome and encouraged to attend this program.

## Practice Spotlight: BMP Explanation to New Homeowner


You worked hard to install a rain garden, disconnect your downspouts, plant a riparian buffer, garden with native wildflowers or install other watershed friendly practices on your property. Don’t let that effort go to waste when you

decide to sell your home. Make sure the new owners recognize and understand the

practice so that they can continue the good work that you started.

Many people are unaware of the need for these types of practices and would unknowingly replace them with more traditional landscaping. Selling property is a great time to pass on knowledge. Informing your realtor of the practices is also a good tip since they can be on the lookout for practices in other locations as well.

Providing maintenance instructions by writing out a short



checklist is also a good idea so that the new owner learns how to take care of these precious investments.



## Conewago Partner Spotlight: Elizabethtown Area Water Authority

The Elizabethtown Area Water Authority (EAWA) has been engaged with the Conewago Creek Initiative for several years but has recently increased their level of involvement as they begin to tackle the project of educating their customers on the importance of stormwater management.
